Friday, 2:47 PM. Process server hands me papers.

**Total damage in 48 hours: \$18,200. Five mistakes. One completely destroyed custody case.**

## ■ DISASTER #1: "Just Hire an Attorney Immediately"

**Everyone says:** "Get a lawyer. They'll tell you what to do."

### Reality check:

- TIME TO ACTUALLY TALK TO AN ATTORNEY: 2-4 weeks
- COST JUST TO START: \$5,000-\$15,000 retainer

By the time you get that first meeting, you've already:

- Sent the hostile texts (\$1,800 each to defend)

## ■■ DISASTER #3: Co-Parenting Apps Only

\$99-\$299/year for fancy text logging. Zero guidance on what NOT to write. My mistake: documented hostile message perfectly for court (\$2,800 damage).

**The Reality:** Apps are tools, not strategies. Month 6 solution for Hour 1 problem.

## ■■■ DISASTER #4: Custody Consultants

\$200-\$400/session × 8-12 sessions = \$3,200-\$4,800. Takes 3-6 weeks. Great advice... three weeks too late.
